- In 2022 we hired a new Wyoming Director who now offers programs and services to the nearly 5,000 people with epilepsy in Wyoming.
- In our commitment to diversity and inclusion, our Hispanic Outreach Program engaged more than 200 Spanish-speaking individuals in epilepsy education, support groups and direct support.
- Our special events such as the Walk to END EPILEPSY and the Summits & Stars Gala brought together more than 3,000 people to raise awareness and build community.



EDUCATE

• Our information and referral team is geographically and linguistically diverse, responding to more than 600 emails, calls, and meetings to provide information, resources, case management, and more than \$7,000 in emergency financial assistance.



- We partnered with the State of Colorado and various community agencies to implement "Joey's Law" which requires all public schools in Colorado to have at least one person on staff who is trained in seizure recognition and first aid, ensuring that all students with epilepsy will have an adult at school who knows how to properly care for them.
- We launched a new and improved website to offer better access to information and resources to support people impacted by epilepsy.



EMPOWER

• More than 50 individuals participated in our mental health programs, including 18 individuals who completed PACES, a skill-building program that helps improve self-management of their health condition and improve the overall quality of life.



- In partnership with our local representatives and other health organizations we helped pass HB22-1370, which will make healthcare more affordable and dependable by reforming step therapy and prohibiting insurers from making changes to coverage mid-contract.
- Our advocacy volunteers led the effort to create an Epilepsy Awareness Colorado License Plate, which is available now!
